Evaporation Rule Win

Lachlan Valley Water met with DPE on 15 Dec 23 regarding the Evaporation Rule and its application. In summary, the rule agreed to during the 2018 SAP (what we were asking for) will be applied going forward, with water debited in September under the "current" rule being re-credited, and the 2018 rule retrospectively applied to quarter one, and then from quarter 2 onward – evaporation will be published quarterly. An evaporation transaction note will appear on the statement at the date of deduction showing the volume of reduction, and a total "year to date" will be displayed in the Allocations Totals Summary, below the transaction report. A dedicated webpage and factsheet will be made available early in the new year.

It's important to note that evaporation still doesn't apply to High Security Spill accounts.

This representants a significant "win" for Lachlan Valley Water and our members and is a great example of what Lachlan Valley Water does for water users in the catchment. Please mention this when talking to any non-members, to highlight the importance of belonging to LVW so as to continue to fund the important advocacy work that we do. It took a number of meetings, letters, phone calls, a media release (and resulting publicity), and some effort by all involved to get us to this point. Special thanks and acknowledgment to Tom Green, Nick Turner, and Ed Fagen for all their work in driving this result.

River Operations

Wyangala Dam – 92.5%, with inflows of 2.53GL and release of 0.8GL.

A type of environmental water, called Water Quality Allowance or WQA, is now being used to increase base flow in Lachlan River below Willandra Weir. As the name would imply, the aim is to reduce the risk of acute water quality issues emerging over summer.

An additional 100 ML/day is being added to other types of water in the river, targeting flows >150 ML/day at Booligal gauge through January. The delivery period Lachlan River @ Willandra Weir is 20/12/2023 to 18/1/2024. The delivery period at Booligal is 1/1/2024 to 31/1/2024 (given that travel time is 13 days). The WQA will be reviewed on 15 Jan 24 and may be extended if required.

Lake Brewster – 69.7%

Lake Brewster is still 'off-line' for Australian pelican management so a mix of water is being used from upstream of Brewster Weir — but expecting normal operations to resume at Lake Brewster 1 January 2024 (pending water quality within the storage system itself at the time although no major issues at the moment). Water has continually been circulated through Lake Brewster storage system to avoid stagnant water and mitigate risk of algal blooms etc.

Lake Cargelligo – 67.0%.

Construction areas closed from 22 Dec 23 and will reopen Monday 8 Jan 24. Water levels will be kept at no more than 70%.

Carcoar Dam – 98.9%, inflows of 0.03GL. A Supplementary Flow began on Tuesday 26 Dec 23, and will finish at 9am Tuesday 2 Jan 24.

WaterNSW Operating Licence Review.

This report sets out draft recommendations for how WaterNSW's operating licence should change to better

meet its objectives for the next 5 years. IPART seeks to ensure that the licence remains current and reflects changes in public expectations, best practice and WaterNSW's circumstances. This report also sets out draft recommendations for how the operating licence should change to better meet its objectives and resolve issues that have arisen during the term of the current licence that may impact its effectiveness.

WaterNSW Pricing Proposal

As part of their pricing policy engagement WaterNSW has released their "Phase 1 Customer and Community Insights Report" as a result of consultation by SEC Newgate. It's a pretty wordy document (some 120 pages long) with a lot of transparency around how the engagement has conducted and breaking down the results. In essence, I'm comfortable that all of our concerns/questions have been included, however we need to try and ensure that they are not lost or deprioritised as a result of the rest of the "noise" contained in the document. The report considers general statewide feedback and engagement as well as that at valley level. If nothing else it highlights the need to get involved with CAGs and Working Groups to ensure we have sufficient representation during these engagements. While WAL holders represent some 85% of WaterNSW's customers on state basis, industry is significantly unrepresented (by way of numbers) in the working groups. The next round of working groups will start in Feb 24; if you'd like to come along please let me know and I'll ensure you receive an invite.
