Lachlan Valley Regional Water Strategy

The draft Lachlan Regional Water Strategy will be on public exhibition until 12 November 2023, which is when submissions are due. Information webinars conducted on 10 & 13 October have been recorded and are available to view. River Operations

Wyangala Dam is currently sitting at 95%, releasing 1200ML per day from 4.30pm on Saturday 4th of November 2023. Lake Brewster is at 74.2% and Lake Cargelligo has reduced from 50.9% last month to 48.1% this month as a result of demand downstream. Carcoar Dam is sitting at 98% with little forecasted orders at this stage. It's likely that due to environmental needs and limitations of the repairs that Lake Cargelligo will sit at a maximum of 75% until at least the end of the calendar year.

WaterNSW Water Use Survey

WaterNSW Water Planning & Delivery South have recently sent a survey to WAL holders, to help forecast water demand for November 2023. WaterNSW are looking to convert future water usage surveys into a more user-friendly format, however in the interim they will be in MS Word. Meeting with NSW Water Minister

Last week Tom Green, Nick Turner and I (Glenn Daley) met with the NSW Water Minister Rose Jackson in her Sydney offices. We discussed WaterNSW's performance since the restructure including the significant increase in cost to the Lake Cargelligo embankment project and their lack of transparency, in addition to our disappointment with the "hollow" Lachlan Regional

Water Strategy. The Minister advised she shared our concerns regarding the Lake Cargelligo project and advised us to meet with her again to discuss once we'd had an opportunity to make comment on WaterNSW's Pricing Proposal to IPART later in the year. She further encouraged us to provide her detail on what projects/actions that we'd like to see included in the Regional Water Strategy.

Minister's Visit to Orange

The NSW Minister for Water Rose Jackson visited Orange last week to meet with locals and local government to discuss drought mitigation. During her visit she provided progress on a \$6.2 million infrastructure project to boost water security for townships during dry conditions. The project, which can be used in emergency drought conditions includes:

- \$5.5 million to connect Cowra and the Central Tablelands Water (CTW) systems, so the region can share water when supplies hit critically low levels.
- \$150,000 to help Central Tablelands Water bring plans to upgrade its water mains network to the tender-ready stage.
- \$577,500 for Cabonne Shire Council to accelerate investigative works that will determine the best infrastructure options to help future proof water for its residents.

Non-Urban Metering Review

The non-urban water metering review public consultation paper was released last week with **submissions due on Sunday 26 November 2023**. During this period, DPE Water will facilitate **online information sessions** targeted at each region. These sessions will be held on:

- Northern Inland Monday 13 November 9:30 to 11:00am
- Southern Inland Monday 13 November 2:00 to 3:30pm

Productivity Commission Report

The Productivity Commission released its interim Murray Darling Basin Plan report last week. Key findings from the submissions include:

- 61 per cent of submissions overall do not support the Bill, rising to 79 per cent of submissions from within the Basin.
- 56 per cent do not support water buybacks, rising to 76 per cent of submissions from within the Basin.
- 68 per cent of submissions support socioeconomic impact conditions on water buybacks, rising to 84 per cent of submissions from within the Basin.
- 100 per cent of Murray-Darling Basin local government submissions oppose the Bill.
- Most submissions support complementary measures to fix river health.

The Commission seeks feedback on the interim report by Monday 20 November 2023.
